ORDER OF RESTORATION OF RECOGNITION

WHEREAS, the institution Bhagwan Mahaveer College of Education, 31, Milestone, Shakti Complex, G.T. Road, Behind IOC Petrol Pump, Kundli-131028, Distt. Sonapat, Haryana was granted recognition for the following courses:

1. Order No. F.NRC/NCTE/F-3/HR-417/6284-6293 dated 29.09.2006 for B.Ed. course with an annual intake of 100 (One Hundred Only) students, Order No. F.NRC/NCTE/F-7/HR-655/2007/29073-79 dated 28.09.2007 for B.Ed. additional intake with an annual intake of 100+100=200 (Two Hundred Only) students and Order No. NRC/NCTE/F-7/HR-1187/2008/49506-512 dated 14.05.2008 for B.Ed. additional Intake with an annual intake of 100+100+100=300 (Three Hundred Only) students.
2. Order No. NRC/NCTE/F-7/HR-652/2007/29562-74 dated 3.10.2007 for M.Ed. course with an intake of 25 students & Order No. NRC/NCTE/F-7/HR-1149/2008/49478-84 dated 14.05.2008 for M.Ed. additional Intake with an annual intake of 25+25=50 (Fifty Only) students.
3. Order No. F.NRC/NCTE/F-3/HR-418/8305 dated 14.11.2006 for D.Ed. course with annual intake of 50 (Fifty) students. Order No. NRC/NCTE/F-7/HR-654/2007/29581-87 dated 03.10.2007 for D.Ed. additional intake with an annual intake of 50+50=100 (One Hundred Only) students and order No. NRC/NCTE/F7/HR1206/49513-19 dated 4.5.2008 for D.Ed. additional intake with an annual intake of 50+50+50=150 (one hundred fifty only) students.

AND WHEREAS, the recognition of the institution was withdrawn for all the above courses vide NRC order No. F.NRC/NCTE/F-3/HR-1187/2010/24006 dated 22.6.2010.

AND WHEREAS, a letter dated 01.05.2012 & 07.05.2012 received from the institution in which is enclosed a court order dated 08.02.2012 in C.W.P. No. 11460/2010 and C.W.P. No. 11336/2009 in the Hon'ble High Court Punjab and Haryana at Chandigarh which is reproduced below:-

"In case the petitioner fulfils the norms as prescribed and required under the guidelines issued by the NCTE, the recognition which has been withdrawn be restored. Interim order dated 7.7.2010 passed by the Court shall be applicable to the students who have now been admitted for the session 2011-2012. In the light of the fact that students have been assigned to the petitioner-institute by respondent No. 4 State Council of Education, Research and Training (SCERT), Haryana for the session 2011-2012, petitioner be issued the examination forms by respondent No. 3 for D.Ed. course and thereafter proceeded with the matter in accordance with the rules, regulations and ordinances of the University and the Board. This order shall not confer any equity or right on the petitioner-institute of the students of the institute of claim any benefit in this regard. List for further consideration on 25.7.2012".

AND WHEREAS, the matter was considered by NRC in its 199th meeting held from May 22-27, 2012 and the NRC decided the following:-

In compliance of the order of Hon'ble High Court of Punjab and Haryana, VT is constituted to inspect the new premises of the institution i.e. Bhagwan Mahaveer College of Education, Village - Jagdishpur, Near Railway Crossing, Distt. Sonapat, Haryana. Accordingly, letter was issued to the institution on 07.06.2012

AND WHEREAS, the inspection of the institution was conducted shifting of premises on 19.06.2012, and the matter was considered by the NRC in its 200th Meeting of NRC held from 20th - 24th June, 2012 whereby the NRC decided the following:-



"The original file of the Institution and other related documents submitted by the institution along with other related documents, NCTE Act, 1993, Regulations and Guidelines of NCTE published from time to time has been carefully considered by NRC. As per the directions of the Hon'ble High Court, VT was constituted for shifting of the premises.

After considering the Visiting Team Report, NRC decided to allow the shifting of premises under clause 8(11) of NCTE Regulations, 2009."

AND WHEREAS, as per the above decisions of the NRC a letter dated 03.07.2012 has been issued to the institution allowing therein to shift its premises to Bhagwan Mahaveer College of Education (Khasra No. 43/12, 43/13, 43/18 & 43/19), Village Jagdishpur, Distt. Sonapat, Haryana under clause 8(11) of the NCTE Regulation, 2009. The case of the institution was again considered by the NRC in its 209th meeting held from 26th to 28th December, 2012 in view of the recognition status of the institution and the NRC decided the following:-

"The original files of the Institution along with other related documents, NCTE Act, 1993, Regulations and Guidelines of NCTE published from time to time has been carefully considered by NRC.

The Committee discussed and considered the case in detail and noted that the NRC in its 200th meeting in compliance of the order of the Hon'ble High Court of Punjab & Haryana has already allowed the institution to shift its premises under clause 8(11) of the NCTE Regulation, 2009, therefore, the recognition withdrawn shall stand continue the for derecognized courses. Accordingly order for restoration of recognition be issued."

NOW THEREFORE, in exercise of powers vested under the NCTE Act, 1993, the recognition of the institution shall stand for the above derecognized courses and the Northern Regional Committee hereby restore the recognition for the withdrawn courses i.e. B.Ed., M.Ed. & D.Ed. with all additional intake of **Bhagwan Mahaveer College of Education (Khasra No. 43/12, 43/13, 43/18 & 43/19), Village Jagdishpur, Distt. Sonapat, Haryana** as per provisions of the NCTE Act, Rules & Regulations.
